As you are aware that the establishments processing Fish and Fisheries Products are approved and monitored as per Govt. of India Order and Notification No S.O. 729(E) and S.O. 730(E) respectively, both dated 21<sup>st</sup> Aug 1995.

Further as per the FSS ACT 2006 every food business operator in the country needs to take either registration or licence as per applicability under the said Act. Since there is duplication of inspection, the matter regarding waving off inspections of Food Business Operator (FBO) by FSSAI was taken up by EIC with FSSAI. FSSAI in principle has agreed to wave off the inspections. if the FBO is already approved by EIA's.

In view of above, I am directed to inform you that, Inspection reports of approved fish and fisheries products establishments by EIC may be sent to concerned Designated Officer (DO) of FSSAI as per the area of jurisdiction. List of Designated Officers (DO) is enclosed for ready reference, further on the strength of the inspection reports of EIA, FSSAI shall grant the licences to FBO.

In order to speed up the matter, SO's may be advised to send inspection reports directly to DO under intimation to HO and EIC.
