Action Taken Report

The Council noted the action taken on the minutes of the last meeting of the Council with suggestion on the following:

Item No. 2.6.i (ii)

- 1. Chairman, MPEDA suggested that while making investments gainfully in the banks, it would be better if only Nationalized Banks are considered. New generation banks be avoided so as to minimize/eliminate the risk of investments.
- 2. While inducting an officer for Finance, clear qualifications namely CA/MBA(Finance) to be laid down.

On a query raised by Chairman, MPEDA, it was clarified that sanctioned strength was only Agency-wise and not Sub-officewise and therefore all employees are considered within the overall sanctioned strength and closure of sub-offices would not make any difference in the overall sanctioned strength.

Shri Anwar Hashim pointed out that in pursuance of the executive instructions issued by EIC, EIA-Cochin is insisting for organoleptic inspection as a result, there is lot of resentment in fish trade in Cochin.

It was clarified by EIC that requirements of organoleptic quality were included in both the EC regulation as well as EIC notification in view of which it was considered necessary to make it a part of the EIA's control procedures.

After a great deal of discussion on the subject, it was decided that organoleptic evaluation would need to form a part of our control measures. However, to make it as objective as possible, specific parameters to be covered under organoleptic evaluation may be elaborated. The trade was requested to assist in development of these parameters.

The meeting ended with a vote of thanks to the Chair as well as for other members for their valuable support to the EIC.
