ORDER

In exercise of the powers conferred by sub-rule 6.4 of rule 6 of the Export of Fresh, Frozen and Processed Fish and Fishery Products (Quality Control and Inspection and Monitoring) Rules, 1995, as amended, the Competent Authority hereby recognizes the Marine Products Export Development Authority having its headquarters at Kochi as a 'Registering Authority' to register hatcheries for supply of juvenile fish or crustaceans caught when juvenile to aquaculture farms approved under Rule 11 of the said Export of Fresh, Frozen and Processed Fish and Fishery Products (Quality Control and Inspection and Monitoring) Rules for exports, subject to following conditions:

- 1. For the purpose of registration of hatcheries under this Order, the Marine Products Export Development Authority shall ensure that the applicant possesses ownership right, either free hold or lease hold for a period not less than 2 years.
- 2. The Marine Products Export Development Authority shall ensure that the registration numbers to be allotted to the hatcheries are unique and are not in conflict with the numbering system followed by the Coastal Aquaculture Authority.
- 3. The Marine Products Export Development Authority shall give adequate facilities to the officers nominated by the Competent Authority to audit the system of registration followed by them.
- 4. The Marine Products Export Development Authority, in the performance of their functions under this order shall be bound by such directives as the Competent Authority may give in writing from time to time.
