





Monthly Report- December 2015

Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in December 2015 were 95. Out of 95 notifications, 26 notifications were the addendum of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 95 Notifications, 27 were related to food products, 13 related to machinery products, 8 related to electrical products, 7 related to chemical, 6 related to fuel, 6 related to pharmaceutical products, 4 related to auto & auto components, 3 related to cosmetics, 3 related to medical device, 2 related to tobacco, and the remaining 16 Notifications were related to other products.

Country-wise Information: Out of the total 95 notifications, United States of America issued 14 notifications, followed by Saudi Arabia, Argentina, European Union, China, Egypt, Malaysia, Chinese Taipei, Brazil, Japan, Nigeria and Thailand with 11, 6, 6, 5, 5, 5, 4, 3, 3, 3 and 3 Notifications, respectively. The remaining 24 Notifications were from other WTO Member countries.

Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for 41 Notifications. The responses were received from Albania and Korea. However, the responses from the rest of the countries are awaited.
