






Notification Details:

Country-wise Information: Out of a total 199 notifications in July 2014, Ecuador issued 23 notifications, followed by Oman, USA, Canada, Brazil, Mexico, Saudi Arabia, EU, Korea and Kuwait, respectively. The remaining 54 notifications were from other WTO Member countries.

Product-wise Information: Out of total 199 notifications 69 related to food and food products , 15 related to electrical equipment, 12 related to pharmaceuticals , nine related to Automobiles , six are related to Home appliances and the remaining 88 notifications are related to textiles, tobacco, seed, construction ,plastic , hazardous substance, fuel , steel, , medical, coffee , milk, paint , petroleum , cosmetics and chemicals.

Request for relevant regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for 21 notifications to 10 countries.

- a. We received responses from South Korea, Saudi Arabia, Mexico, Cuba, and Colombia.
- b. Out of these 5 responses, Saudi Arabia, provided copies of English version of Regulation of four notifications.
- c. Other countries like South Korea, Cuba, Mexico, and Colombia has responded that they do not have an English version of regulation.
- d. In addition to this, Chile, Oman, Denmark, Ecuador and Malaysia have not yet responded to our request.
