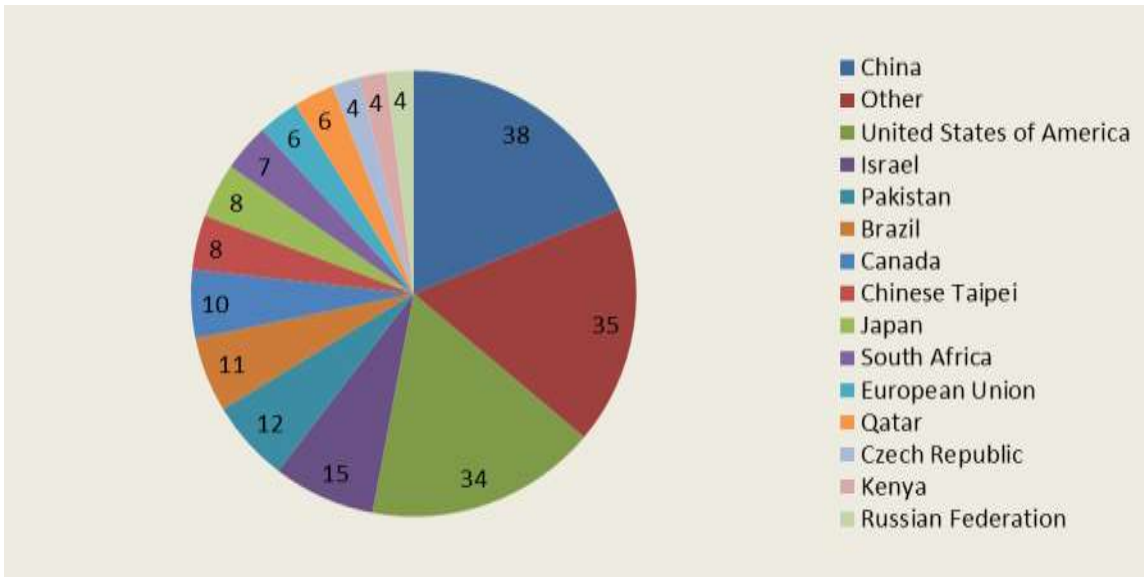

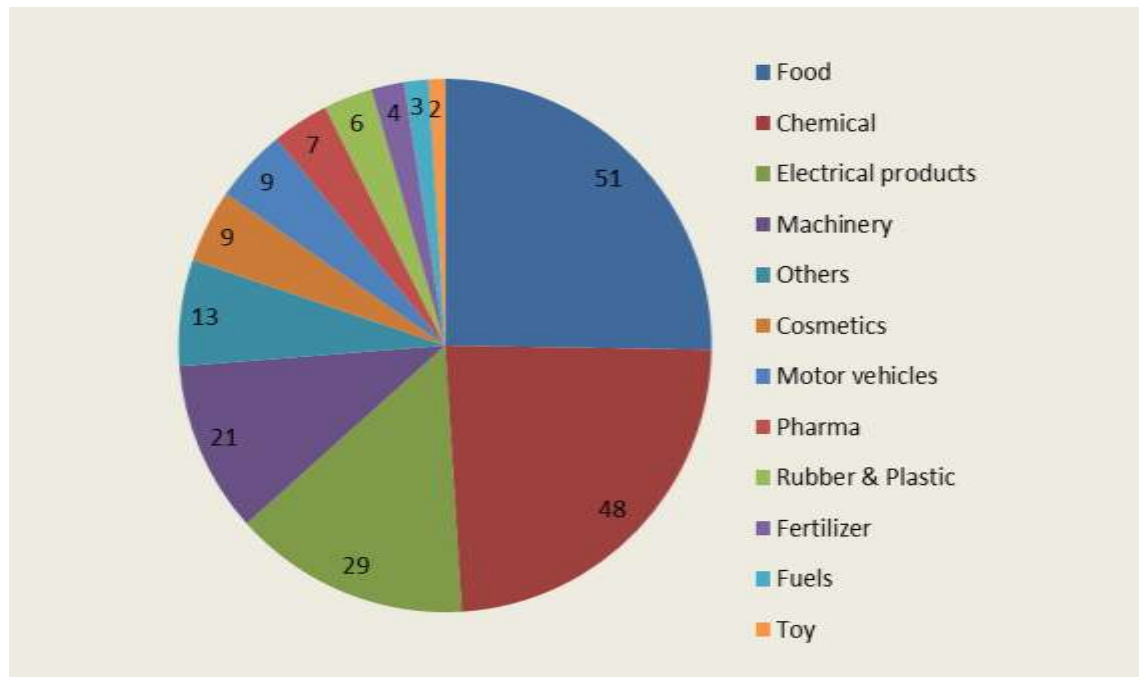

Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in July 2015 were 202. Out of 202 notifications, 55 notifications were the addendum of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 202 Notifications, 51 were related to food products, 48 related to chemical, 29 related to electrical products, 21 related to machinery, 9 related to cosmetics, 9 related to motor vehicles, 7 related to pharmaceutical, 6 related to rubber & plastic products, 4 related to fertilizer, 3 related to fuels product, 2 related to toys and the remaining 13 Notifications were related to other products.

Country-wise Information: Out of the total 202 notifications, China issued 38 notifications, followed by United States of America, Israel, Pakistan, Brazil, Canada, Chinese Taipei, Japan, South Africa, European Union, Qatar, Czech Republic, Kenya and Russia with 34, 15, 12, 11, 10, 8, 8, 7, 6, 6, 4, 4 and 4 Notifications, respectively. The remaining 35 Notifications were from other WTO Member countries.

Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for 71 Notifications. The responses were received from China, Korea, and Pakistan. However, the responses from the rest of the countries are awaited.
