
### TBT MONTHLY REPORT (JULY 2017): AT A GLANCE

# **Details Pertaining to TBT Notifications Issued By WTO Member Countries**

The total numbers of TBT Notifications issued by the various WTO-Member Countries in July 2017 were 163. Out of 163 notifications, 97 notifications were the addendum of draft regulations notified earlier in the WTO.

#### **Details Pertaining to TBT Notifications Relevant To India**


**Product-wise Information:** Out of the total 163 Notifications, 56 related to food, 18 related to machinery, 13 were related to chemical products, 10 related to auto and auto component, 9 related to iron & steel, 7 related to fuel, 6 related to cosmetic, 6 related to electronic products and appliances, 6 related to pharmaceutical product, 5 related to wood products, 4 related to construction, 3 related to communication equipment and 20 notifications were related to other products.



**Country-wise Information:** Out of the total 163 notifications, Uganda issued 51 notifications, followed by United States of America, Chile, Brazil, European Union, Chinese Taipei, Vietnam, Mexico, China, Singapore, Switzerland and Turkey with 24, 12, 10, 7, 6, 6, 5, 4, 4, 4 and 4



Notifications, respectively. The remaining 26 Notifications were from other WTO Member countries.





# **ANALYSIS OF TBT NOTIFICATIONS**

The monthly report is divided into two sections.

## A. Section A: Request For Regulation

In case of certain notifications, the member countries have not provided the regulation associated to the respective notification. In other cases, certain member countries have provided the regulations in their local language only but not in English. In these cases, a request has forwarded to the concerned enquiry points seeking the regulations in English so that these can be analyzed on time.

### B. Section B: TBT Notifications Relevant to India

This section covers details of notifications which are relevant to India and where a letter has forwarded to all relevant and interested stakeholders seeking their comments on the notification. Stakeholders include individual exporters, organizations, associations and government departments representing the product mentioned in these notifications.



## A. Section A: Request For Regulation

In July 2017, there were 105 notifications where the notifying countries either have not provided any regulation or provided the regulation in their local language. We have sent requests to the concerned enquiry points seeking the regulation preferably in English. Despite of regular follow-up the member countries have not responded/provided the regulations (in English) and their responses are still awaited. However, letters have been forwarded to the relevant stakeholders based on the information available on the TBT notifications. Please find Section B for more details of these 105 notifications.
