






Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in June 2015 were 133. Out of 133 notifications, 29 notifications were the addendum of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 133 Notifications, 26 were related to food products, 12 related to Auto, 12 related to chemical, 11 related to electrical products, 11 related to machinery, 7 related to cosmetics, 4 related to pharmaceutical, 3 related to children's products, 3 related to tobacco, 2 related to textiles product and the remaining 42 Notifications were related to other products.

Country-wise Information: Out of the total 133 notifications, United States of America issued 15 notifications, followed by China, Pakistan, European Union, Pakistan, Canada, Ecuador, Saudi Arabia, Brazil, Chile, Kuwait, Mexico and Chinese Taipei with 14, 13, 11, 7, 6, 6, 5, 5, 5 and 4 Notifications, respectively. The remaining 38 Notifications were from other WTO Member countries.

Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for 40 Notifications. The responses were received from China, Oman, and Saudi Arabia. However, the responses from the rest of the countries are awaited.
