






AT A GLANCE

Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in November 2014 were 168. Out of 168 notifications, 44 notifications were the adoption of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 168 Notifications, 67 were related to food products, 13 related to auto products, 4 related to steel products, 23 related to electrical products, 4 related to toys, 16 related to pharmaceutical products and the remaining 41 Notifications were related to other products.

Country-wise Information: Out of the total 168 notifications, Saudi Arabia issued 24 notifications, followed by Panama, Kenya, Bahrain, Taiwan, USA, Ecuador, Brazil, EU, Canada and Japan with 18, 16, 15, 13, 12, 9, 8, 8, 6 and 6 Notifications, respectively. The remaining 33 Notifications were from other WTO Member countries.

Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for **59 Notifications**. The responses were received from Saudi Arabia, Korea, Ecuador, Bahrain, United Arab Emirates and South Africa. The English version of the draft regulation was provided by Bahrain, United Arab Emirates and South Africa. However, Saudi Arabia responded that the standards mentioned in the Notifications are adaptations of International Electrotechnical Committee (IEC) standards.
