






Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in November 2015 were 131. Out of 131 notifications, 44 notifications were the addendum of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 131 Notifications, 58 were related to food products, 19 related to machinery products, 12 related to electrical products, 9 related to chemical, 9 related to pharmaceutical products, 5 related to textiles products, 4 related to vehicle products, 3 related to medical device, 2 plastic & rubber products and the remaining 10 Notifications were related to other products.

Country-wise Information: Out of the total 131 notifications, United States of America issued 25 notifications, followed by Saudi Arabia, Brazil, Korea, Bahrain, Czech Republic, Japan, Kuwait, Oman, United Arab Emirates, Yemen, Ecuador, Qatar, Argentina and Kenya with 8, 7, 7, 6, 6, 6, 6, 6, 6, 6, 5, 5, 4 and 4 notifications, respectively. The remaining 24 Notifications were from other WTO Member countries.
