TBT Notifications (1st of October 2015 to 31st December 2015)

I. Notification Details:

The total number of notifications issued by the various WTO-member countries from 1st of October 2015 to 31st December 2015 was **520**. The notifications are divided into three categories: active notifications, notifications sent for request for regulation and the notifications with negligible exports. The active notifications are those notifications where India has export potential on the products referred and also have regulations available in English version. There are another group of notifications where the regulations are not available in English language. The last category comes under the no export category where India is not exporting the products referred in these notifications or negligible exports are reported. Out of these 520 notifications, **117** were active notifications that were of relevance for India.

II. Active Notifications:

Country-wise Information: An analysis of the 117 notifications which were relevant to India shows that United States of America issued 55 notifications followed by European Union, Japan, Chinese Taipei, Canada, United Arab Emirates, Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and Yemen which issued 14, 9, 7, 5, 5, 4, 3, 3, 3, 3 and 3 notifications, respectively. Together, these countries have issued more than 90% of the total notifications during 1st of October 2015 to 31st December 2015. *(Table 1 below)*

III. Total Notifications Issued by All Member Countries:

Country-wise Information: Out of the total 520 notifications issued by member countries of WTO, United States of America issued 64 notifications followed by Saudi Arabia, United Arab Emirates, China, Bahrain, Oman, Kuwait, Yemen, Qatar, Brazil, European Union, Argentina, Korea, Egypt, Chinese Taipei, Japan, Ecuador, South Africa and Uganda which issued 51, 30, 26, 24, 20, 20, 17, 16, 16, 15, 12, 12, 11 and 11 notifications, respectively. These countries have issued more than 76% of the total notifications during 1st of October 2015 to 31st December 2015. *(Table 2 below)*

Product-wise Information: Out of the 520 notifications, 236 were on food products, 41 were on electrical products, 39 were on machinery, 30 were on chemical, 22 were on pharmaceutical, 21 were on auto & auto components, 13 were on medical device, 12 were on cosmetic, 10 were on textiles, 6 were on fuels, 4 were on iron & steel products, 3 were on tobacco products, 2 were on rubber & plastic and the rest were in other products. **(Table 3 below)**



IV. Indian Position on Notifications Relevant to India:

Notifications-No Impact on Indian Industry:

Based on analysis and industry/stakeholders response on 117 notifications, it was found that, India was in a position to meet 85 regulations proposed by the member countries and on six regulations, the Government of India has sought clarifications from the concerned "Enquiry Points". For 26 notifications issued in December 2015 the responses are yet to be received.

Notifications-May Impact Indian Industry: (Draft Responses Already Sent)

There were six notifications where stakeholders were of the view that, though some of the notifications were in line with International Standards, they may adversely impact Indian exports. Hence, APJ-SLG suggested that the Government of India may seek clarifications from the concerned enquiry point requesting them to provide justification for setting the proposed regulations. These notifications are mentioned below:

Impact Analysis:

The responses were sent to respective enquiry points on notified products that carried an impact for potential export markets for India.

Chinese Notification: G/TBT/N/CHN/1094

In the case of CHN/1094, the draft responses were sent with respect to wood products. The notification was on the control limit of emission of harmful chemical substances. The question was basically asked on deviation from test standards established by International standards Organisation, ISO. India also questioned the scientific justification and enforcement measures of the proposed measure.



UAE Notification: G/TBT/N/ARE/265

The notification dealt with technical regulation for limiting the emission of hazardous substances. India asked for scientific and technical information and measures applicable for products already in the market. Questions related to conformity assessment procedures were also raised in the response to the UAE. The notification put forth stringent regulations restricting the use of four substances on electrical products. India asked for extension of transition period for Indian exporters.

Oman Notification: G/TBT/N/OMN/212

The notification mandated the use of ASTM Standards for children and adult jewellery. The ASTM standard was considered as an international standard. The cost for ASTM standards was too costly for Indian exporters. India questioned the status of ASTM standards as International standards and asked UAE to ease the standards for Indian exporters.

Kenya Notification: G/TBT/N/KEN/122/Rev.1

Kenya mandated the use of conformity certification for all products starting from December 2015. It mandated for an inspection requirement for issuance of certificates of conformity. The presentation of certificate of conformity shall be mandatory for clearance of all products exported to Kenya. This placed huge compliance cost for Indian exporters to Kenya. This measure of Kenya was questioned by India and asked for bilateral consultations with Kenyan authorities on this issue. Kenyan Government has responded to look into the issue.

Singapore Notification: G/TBT/N/SGP/25

Singapore Notification dealt with organic certification of food products. It came up with inspection and certification of organic food products. India asked for equivalence with India's NPOP scheme. Singapore responded that India's Indian Government's NPOP Scheme is based on Codex and IFOAM guidelines, such a certification scheme would be deemed to be equivalent to the Codex guidelines. Therefore organic food products exported from India and duly certified under the NPOP Scheme would be considered to be in compliance with the new requirements to be introduced by Singapore.

USA Notification: G/TBT/N/USA/658.Add.1

US notification dealt with renewal of third party testing procedures for children's products. The manufacturers of children products have to follow all the paperwork associated with the sections therein. This increased the delay of export of children's goods to USA. The same was questioned and the need for such record keeping requirements was also raised with the respective enquiry point.





