


#### **Monthly Report- September 2015**

### AT A GLANCE

#### WTO Members issuing maximum number of TBT Notifications in September'15

#### **Notification Details:**

The total numbers of TBT Notifications issued by the various WTO-Member Countries in September 2015 were 137. Out of 137 notifications, 34 notifications were the addendum of draft regulations notified earlier in the WTO.

**Product-wise Information:** Out of the total 137 Notifications, 27 were related to food products, 18 related to electrical products, 16 related to chemical, 15 related to machinery, 13 related to pharmaceutical, 12 related to paper, 7 related to vehicles, 5 related to auto, 4 related to iron & steel, 3 related to construction products, 3 related to medical device, 2 related to cosmetic, 2 related to textile, 2 related to toy and the remaining 8 Notifications were related to other products.

**Country-wise Information:** Out of the total 137 notifications, United States of America issued 19 notifications, followed by Uganda, Brazil, European Union, Egypt, China, Korea, Mexico, Switzerland, Chile, Albania, Chinese Taipei, Colombia and Kuwait with 18, 11, 10, 9, 8, 8, 6, 6, 5, 4, 3, 3 and 3 Notifications, respectively. The remaining 24 Notifications were from other WTO Member countries.

#### Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for 40 Notifications. The responses were received from Colombia and Korea. However, the responses from the rest of the countries are awaited.
