IMPORTANT

- Candidates already employed in Central / State Govt. Departments / Public Sector / Govt. Undertakings are required to apply through proper channel. In order to avoid delay, applications may also be sent directly. However, in such a case, they have to produce a 'No Objection Certificate' from their employer at the time of their interview.
- ii) Eligible employees of EIC / EIAs can also apply.
- iii) The candidates must write his / her name as it appears in the SSC / Matriculate Certificate. For change of name after SSC/ Matriculation, if any, documentary evidence should be attached.
- iv) Photocopies of relevant documents in support of age, qualifications, experience and caste certificate issued by the Competent Authority must be enclosed with the application.

- v) Separate applications are required for each post. The post applied for must be super scribed on the envelope. The candidates finally selected for the posts mentioned above are eligible for posting in any activity at any of the offices of EIC / EIAs at the sole discretion of the Competent Authority.
- vi) Right for calling the candidate for interview is reserved with the Competent Authority and only the short-listed eligible candidates would be called for interview. No correspondence in this regard would be entertained.
- vii) SC/ST Candidates shall be eligible for reimbursement of to & fro rail fare as per Rules, if called for interview.
- viii) Incomplete applications and applications received after the last date shall not be entertained.
