### ORDER

**Subject: Appeal made by Shri Mohan, Jaipur under Section 19(1) of the Right to Information Act, 2005.**

#### **Facts of the Case:**

Shri Mohan, Jaipur vide his online application dated 17<sup>th</sup> April 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his online RTI application request dated 27<sup>th</sup> February 2018.

Vide his online RTI application dated 27<sup>th</sup> February 2018, Shri Mohan, Jaipur had sought the information regarding certified copies of attendance (manual and biometric) and leave in respect of Shri Sanu Jacob, Joint Director, EIA-Mumbai for the period October, 2017 to February, 2018

CPIO, EIA-Mumbai vide online reply dated 23<sup>rd</sup> March 2018, provided the information to the applicant.

Aggrieved by the reply of CPIO, EIA-Mumbai, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his online application dated 17<sup>th</sup> April 2018.

The applicant, in his appeal, has requested to provide the information.


