Amendment No. 1 to the Doc. No. EIC/ Health Certificate Scheme for Food Commodities / October 2012 / Issue 1 of Clause 4 of last but 1 para is amended as below;

Sample shall be drawn from one in **fifty consignments or once in a year whichever is earlier** for testing as per the requirement of the importing country for maintaining data base (Exporter wise). Health certificate shall be issued only after satisfactory test report/s. The cost of the testing shall be borne by the exporter / processor.
