Amendment in Document No. Document No. EIC/Honey Ex. Instruction /September, 2008/Issue – 3

Clause no 2.3.9

“If satisfied, the In-charge of the Agency shall grant the approval of the establishment for a period of one year from the date of the conditional approval, which shall be intimated to the unit as per the format specified at **Annexure VII (Pg. 83)** with a copy marked to EIC”.

May be read as

“If satisfied, the In-charge of the Agency shall grant the approval of the establishment for a period of **Two** years from the date of the conditional approval, which shall be intimated to the unit as per the format specified at **Annexure VII (Pg. 83)** with a copy marked to EIC”.

Clause No.5.2.2

“In case the IDP recommends renewal of approval and the in-charge of Sub-Office submits the satisfactory performance report as per the Annexure XIV (Pg. 105) the In-charge EIA shall grant the renewal of approval for a period of one year from the date of expiry of earlier approval and inform the establishment accordingly, with a copy marked to EIC”.

May be read as

“In case the IDP recommends renewal of approval and the in-charge of Sub-Office submits the satisfactory performance report as per the Annexure XIV (Pg. 105) the In-charge EIA shall grant the renewal of approval for a period of **Two** years from the date of expiry of earlier approval and inform the establishment accordingly, with a copy marked to EIC”.
