## ORDER

Subject: Appeal made by Ms. Deepika Singh, Haryana under Section 19(1) of the Right to Information Act, 2005.

## Facts of the Case:

Ms. Deepika Singh, Haryana vide her application dated $21^{\text {st }}$ July, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against her RTI application request dated $13^{\text {th }}$ June, 2018.

Vide her RTI application dated $13^{\text {th }}$ June, 2018, Ms. Deepika Singh, Haryana had sought the information regarding details of IFE Workshop 2018 at EIA-Mumbai.

CPIO, EIC vide online reply dated $12^{\text {th }}$ July, 2018, provided the information to applicant.
Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide her online application dated $21^{\text {st }}$ July, 2018.

The applicant, in her appeal, has requested to provide the complete information.
CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.

## Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Ms. Deepika Singh.
