Subject: Appeal made by Shri Ajay Kapoor, Tamil Nadu under Section 19(1) of the Right to Information Act, 2005.

Facts of the Case:

Shri Ajay Kapoor, Tamil Nadu vide his application dated 29th August, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 25th July, 2018.

Vide his RTI application dated 25th July, 2018, Sh. Ajay Kapoor, Tamil Nadu had sought the information regarding details of interview for the post of AD(T) under PH category, Vacancy No. 1213/02, Advt. No. 2014/01.

CPIO, EIC vide reply dated 23rd August, 2018, provided the information to the applicant

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal uncer Section 19 (1) of the Right to Information Act, 2005 vide his application dated 29th August, 2018.

The applicant, in his appeal, has requested to provide the complete information.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CFIO. EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Ajay Kapoor.
