## ORDER

**Subject: Appeal made by Shri Pushpa Kumar, Tamil Nadu under Section 19(1) of the Right to Information Act, 2005.**

### Facts of the Case:

Shri Pushpa Kumar, Tamil Nadu vide his application dated 10<sup>th</sup> October, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 10<sup>th</sup> September, 2018.

Vide his RTI application dated 10<sup>th</sup> September, 2018, Sh. Shri Pushpa Kumar, Tamil Nadu had sought the information regarding details of shrimps export during 2013-14 to 2017-18.

CPIO, EIC vide reply dated 10<sup>th</sup> October, 2018, informed the applicant that the requisite information cannot be provided as the same is exempted as per clause no. 8(1)(e)

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his application dated 10<sup>th</sup> October, 2018.

The applicant, in his appeal, has requested to provide the information.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.

### Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Pushpa Kumar.
