

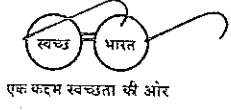

ORDER

Subject: Appeal made by Shri Praveen Sakhuja, Delhi under Section 19(1) of the Right to Information Act, 2005.

Facts of the Case:

Shri Praveen Sakhuja, Delhi vide his application dated 29th November, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 07th August, 2018 (received from DoC vide letter dated 14th August, 2018).

Vide his RTI application dated 07th August, 2018, Shri Praveen Sakhuja, Delhi requested to provide certified copy of letter dated 07th June, 2018, EIC's office order dated 04th June, directions from Vigilance Division, file noting records, Action Taken Report (ATR) & FIR submitted by EIC to DoC.

CPIO, EIC vide reply dated 14th September, 2018 and 06th November, 2018 subsequently, provided the information to the applicant.

However, applicant in his appeal dated 29th November, 2018 has stated that he has not received any information despite making payment for copy of FIR.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant vide letter dated 06th November, 2018 and they state that they have nothing to append.

Orders:

The CPIO, EIC has already provided the copy of complaint lodged, to the applicant vide letter dated 06th November, 2018 (copy enclosed for reference).

This disposes off the appeal of Shri Praveen Sakhuja.
