## **ORDER**

Subject: Appeal made by Shri Praveen Sakhuja, Delhi under Section 19(1) of the Right to Information Act, 2005 – RTI Application No. EIA-Delhi / EIA-2018-003 – reg.

### Facts of the Case:

Shri Praveen Sakhuja, Delhi vide his application dated 29<sup>th</sup> November, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 15<sup>th</sup> October, 2018.

Vide his RTI application dated 15<sup>th</sup> October, 2018, Shri Praveen Sakhuja, Delhi had sought the information regarding certified copies of file notings related to memos dated 03.05.2012, 26.08.2013 and Appeal rejected on 07.07.2015.

CPIO, EIC vide reply dated 15<sup>th</sup> November, 2018, has informed the applicant that "the information sought is voluminous and, searching & providing the same would require serious disproportionate diversion of meagre resources of the organization in terms of section 7(9) of RTI Act. However, if required, applicant may consider to seek specific information in the matter".

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his application dated 29<sup>th</sup> November, 2018.

The applicant, in his appeal, has requested for certified copies of the file noting, records of matter related to issuance of charge sheet followed by punishment of reduction of lower post of Junior Scientific Assistant in August, 2013 and disposal of Appeal by Chairman in matter of Shri Praveen Sakhuja (Applicant).

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already informed the applicant to seek specific information and they state that they have nothing to append.

#### Orders:

The applicant is already informed to seek specific information.

This disposes off the appeal of Shri Praveen Sakhuja.
