

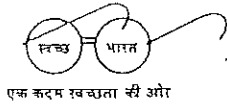

ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Praveen Sakhuja vide his application dated 31st July, 2019 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application dated 29th May, 2019.

Vide his RTI application dated 29th May, 2019, Shri Praveen Sakhuja had sought the information regarding certified copies of attendance marked in manual register, certified copies of the attendance recorded in biometric machine and leave taken by Dr. S. K. Saxena, Director (Insp. & Q/C), EIC.

CPIO, EIC vide reply dated 28th June, 2019, provided the information as obtained from the concerned division to the applicant.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated 31st July, 2019.

The applicant in his appeal has stated that the CPIO category wise denied the information citing the provision of the 8(1)(j) of RTI Act, 2005.

While going through the concerned file, with regard to certified copies of the attendance register in manual register by Dr. S.K. Saxena, Director (Insp. & Q/C), it is observed that no provision exists in manual register for marking the attendance of Director, (Insp. & Q/C), EIC.

Orders:

CPIO, EIC is directed to attend the RTI application dated 29th May, 2019 and provide information to the applicant (for ii & iii of application dated 29.5.2019) as per provisions of Right to Information Act, 2005 within 15 days of receipt of this order free of cost.

This disposes off the appeal of Shri Praveen Sakhuja.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
