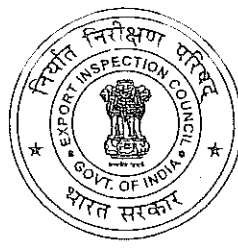



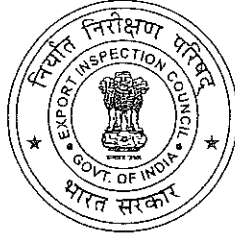

ORDER

Subject: Appeal made by Shri Yogesh Sona, Punjab under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Yogesh Sona vide his application dated 20th September, 2019 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application dated 19th July, 2019

Vide his RTI application dated 19th July, 2019, Shri Yogesh Sona had sought the information regarding Details of Cadre, Functions of EIC, Joining of Dr. Amit Sharma and registered complaints against him.

CPIO, EIC vide reply dated 22nd August, 2019, provided the information as obtained from the concerned division to the applicant.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated 20th September, 2019.

The applicant in his appeal has stated this is clear cut case of wilful negligence of duty. Failure to provide information as per law even in first appeal. Second appeal will be filed in CIC along with reference to CBC.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Yogesh Sona.
