



Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in May 2015 were 106. Out of 106 notifications, 36 notifications were the addendum of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 106 Notifications, 44 were related to food products, 13 related to pharmaceutical & chemical, 12 related to electrical products, 3 related to medical devices, 10 related to Motor vehicle, 7 related to machinery appliances and the remaining 17 Notifications were related to other products.

Country-wise Information: Out of the total 106 notifications, United States of America issued 15 notifications, followed by Bahrain, Ecuador, Brazil, Uganda, European Union, Mexico, Canada, Egypt, Thailand, Viet Nam with 12, 12, 8, 6, 5, 5, 4, 4, 4 and 4 Notifications, respectively. The remaining 27 Notifications were from other WTO Member countries.

Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations/translated copies for 26 Notifications. The responses were received from Korea, Brazil and Saudi Arabia. However, the responses from the rest of the countries are awaited.
