Subject: Appeal made by Smt. Manju Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Smt. Manju Sakhuja vide her letter dated 28th January, 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against her RTI application request dated 29th May, 2015.

Vide her RTI application dated 29th May, 2015; Smt. Manju Sakhuja had sought the information regarding journey of Director, EIC in official staff car since October, 2009.

CPIO, EIC-Delhi vide letter dated 18th June, 2015 stated that information sought is voluminous, runs into various registers/vouchers and compilation/collation of the same would involve diversion of resources of the organization in terms of section 7(9) of the RTI Act. Therefore, the inspection can be done on any working day with 7 days prior notice.

Further applicant vide letter dated 1st July, 2015 proposed for inspection on 7th July, 2015.

CPIO, EIC vide letter dated 6th July, 2015 informed applicant that due to administrative exigencies, inspection could not acceded on the said date. There has not been any further communication from CPIO, EIC to the applicant.

Aggrieved by the reply of CPIO, EIC-Delhi the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide her letter dated 28th January, 2016.

The applicant, in her appeal, has requested to arrange for inspection as requested.

Orders:

CPIO, EIC is directed to re visit the application of applicant and provide suitable response within 10 days of receipt of this order.

This disposes off the appeal of Smt. Manju Sakhuja.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, 2nd Floor, August Kranti Bhawan, Bhikaji Cama Place New Delhi – 110066, within 90 days of the receipt of this letter.
