### ORDER

**Subject: Appeal made by Shri Mohan Lal Swami under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Mohan Lal Swami vide his online application dated 10.02.2017 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 08.01.2017.

The applicant, in his appeal, has requested to provide the complete information.


CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.
