
TBT QUARTERLY REPORT (1ST OF JULY '18 TO 30TH SEPTEMBER '18): AT A GLANCE

Details Pertaining to TBT Notifications Issued By All WTO Member Countries

The total number of TBT notifications issued by the various WTO-member countries from 1st of July 2018 to 30th September 2018 was 879. Out of these 879 notifications, India issued five TBT notifications. Hence, a total of 874 notifications were studied in the quarter 1st of July 2018 to 30th September 2018 which was relevant to India. Out of 874 notifications, 241 notifications were the addendum of draft regulations notified earlier in the WTO.


Details Pertaining to TBT Notifications Relevant To India

Product-wise Information: Out of the total 874 TBT notifications which were relevant to India, 288 related to food products, 65 auto and auto component, 63 related to machinery, 61 related to chemical, 48 electronic products and appliances to fertilizer, 39 related to iron & steel, 25 related to construction, 22 related to measuring instruments, 22 related to paint, 22 related to pharmaceutical, 20 related to communication, 18 related to cosmetic, 18 related to plastic & rubber, 18 related to textile, 15 related to footwear and the remaining 130 related to other products.





Country-wise Information: Out of the total 874 TBT notifications relevant to India, Uganda issued 132 notifications, followed by USA, Brazil, Rwanda, Mexico, Israel, Saudi Arabia, Czech Republic, Kenya, Kuwait, Egypt, UAE, Bahrain, Oman, Tanzania with 60, 42, 39, 35, 32, 31, 28, 28, 28, 26, 26, 24, 24 and 24 notifications, respectively. These countries are among the top 15 TBT notification issuing countries. The remaining 295 notifications were from other WTO Member countries.





Details Pertaining to Responses Sent

Notifications-May Impact Indian Industry: (Responses Sent)

Responses have been sent on 58 TBT notifications in the quarter July 2018 to September 2018. In these notifications stakeholders were of the view that, though some of the notifications were in line with International Standards, they may adversely impact Indian exports. Hence, APJ-SLG suggested that the Government of India may seek clarifications from the concerned enquiry point requesting them to provide justification for setting the proposed regulations.
