
TBT QUARTERLY REPORT (1ST OF OCTOBER '18 TO 31st DECEMBER '18): AT A <u>GLANCE</u>

Details Pertaining to TBT Notifications Issued By All WTO Member Countries

The total number of TBT notifications issued by the various WTO-member countries from 1st of October 2018 to 31st December 2018 was 724. Out of these 724 notifications, India issued one TBT notification. Hence, a total of 723 notifications were studied in the quarter 1st of October 2018 to 31st December 2018 which was relevant to India. Out of 723 notifications, 257 notifications were the addendum of draft regulations notified earlier in the WTO.


Details Pertaining to TBT Notifications Relevant to India

Product-wise Information: Out of the total 723 TBT notifications which were relevant to India, 198 related to food products, 113 related to Chemicals, 53 related to machinery, 37 related to auto and auto component, 28 related to plastic & rubber, 27 related to cosmetic, 27 related to medical device, 26 related to electronic products and appliances, 19 related to construction, 18 related to fuel, 18 related to iron & steel, 15 related to paint & varnishes, 14 related to wood, 10 related to pharmaceutical and the remaining 120 related to other products.





Country-wise Information: Out of the total 723 TBT notifications relevant to India, Uganda issued 142 notifications, followed by USA, EU, Mexico, Rwanda, Kenya, Argentina, Brazil, China, Turkey, Korea, Chinese Taipei, Tanzania, Thailand with 85, 41, 36, 34, 33, 32, 32, 24, 20, 19, 17, 14 and 14 notifications, respectively. These countries are among the top 14 TBT notification issuing countries. The remaining 180 notifications were from other WTO Member countries.





Details Pertaining to Responses

Notifications-May Impact Indian Industry:

Responses are under process for 81 TBT notifications in the quarter 1st of October 2018 to 31st December 2018. In these notifications stakeholders are of the view that, though some of the notifications are in line with International Standards, they may adversely impact Indian exports. Hence, APJ-SLG is in process of preparing responses seeking clarifications from the concerned enquiry point. These notifications are mentioned below:
