
TBT MONTHLY REPORT (AUGUST 2018): AT A GLANCE

Details Pertaining to TBT Notifications Issued By WTO Member Countries

The total numbers of TBT Notifications issued by the various WTO-Member Countries in August 2018 were 288. Out of which, India has issued two notifications. Hence, 286 notifications were studied in August 2018. Out of 286 notifications, 66 notifications were the addendum of draft regulations notified earlier in the WTO.


Details Pertaining to TBT Notifications Relevant To India

Product-wise Information: Out of the total 286 Notifications, 91 related to food, 25 were related to machinery, 23 related to chemical, 20 related to Iron & Steel, 18 related to measuring instruments, 14 related to pharmaceutical, 13 related to electronic products and appliances, 12 related to communication, 9 related to footwear, 6 related to auto and auto component, 6 related to plastic, 6 related to wood, 5 related to fertilizer and 38 notifications were related to other products.





Country-wise Information: Out of the total 286 notifications, Uganda issued 81 notifications, followed by USA, Czech Republic, Brazil, Ecuador, Mexico, Chinese Taipei, Israel, Argentina, Chile, Jamaica, Thailand, European Union and Canada with 26, 21, 14, 14, 14, 13, 10, 8, 8, 8, 7, 6 and 5 Notifications, respectively. The remaining 51 Notifications were from other WTO Member countries.





TBT Notifications Relevant to India

This section covers details of notifications which are relevant to India and where a letter has forwarded to all relevant and interested stakeholders seeking their comments on the notification. Stakeholders include individual exporters, organizations, associations and government departments representing the product mentioned in these notifications.

In August 2018, there were 286 notifications issued by WTO member countries which were relevant to India. Letters have already been sent to their respective stakeholders; however, the responses from the stakeholders are awaited. We are regularly following up on these notifications.
