
TBT MONTHLY REPORT (DECEMBER 2017): AT A GLANCE

Details Pertaining to TBT Notifications Issued By WTO Member Countries

The total numbers of TBT Notifications issued by the various WTO-Member Countries in December 2017 were 167. Out of which, India has issued seven notifications. Hence, 160 notifications were studied in December 2017. Out of 160 notifications, 52 notifications were the addendum of draft regulations notified earlier in the WTO.


Details Pertaining to TBT Notifications Relevant To India

Product-wise Information: Out of the total 160 Notifications, 41 related to food, 24 related to electronic products and appliances, 15 were related to chemical products, 10 related to medical device, 9 related to machinery, 5 related to auto and auto component, 5 related to cosmetics, 5 related to fuel, 5 related to iron & steel, 5 related to plastic, 4 related to communication equipment, 4 related to pesticide, 4 related to wood and 24 notifications were related to other products.





Country-wise Information: Out of the total 285 notifications, Israel issued 29 notifications, followed by United States of America, Chile, Korea, Brazil, Uganda, Chinese Taipei, Tanzania, Canada, Ecuador and Mexico with 15, 11, 11, 10, 10, 8, 6, 5, 5, and 5 Notifications, respectively. The remaining 45 Notifications were from other WTO Member countries.





TBT Notifications Relevant to India

This section covers details of notifications which are relevant to India and where a letter has forwarded to all relevant and interested stakeholders seeking their comments on the notification. Stakeholders include individual exporters, organizations, associations and government departments representing the product mentioned in these notifications.

In December 2017, there were 160 notifications issued by WTO member countries which were relevant to India. Letters have already been sent to their respective stakeholders; however, the responses from the stakeholders are awaited. We are regularly following up on these notifications.
