
TBT MONTHLY REPORT (DECEMBER 2018): AT A GLANCE

Details Pertaining to TBT Notifications Issued By WTO Member Countries

The total numbers of TBT Notifications issued by the various WTO-Member Countries in December 2018 were 166. Out of which, India has issued one notification. Hence, 165 notifications were studied in December 2018. Out of 165 notifications, 43 notifications were the addendum of draft regulations notified earlier in the WTO.


Details Pertaining to TBT Notifications Relevant To India

Product-wise Information:Out of the total 165 Notifications, 49related to food, 13 were related to chemical,13 related to cosmetics, 11 related to iron&steel, 10 related to machinery, 7 related to medical device, 6 related to paint &varnishes,5 related to rubber,4 related to auto and auto component, 4 related to construction, 4 related to fuel, 4 related to pesticide, 3 related to pharmaceutical, 3 related to plastic, 2 related to electronic products and appliances and 27 notifications were related to other products.





Country-wise Information: Out of the total 165 notifications, Kenyaissued 24notifications, followed by European Union, Mexico, Uganda, Brazil, USA, China, Chinese Taipei, Indonesia, Turkey, Argentina, Thailand, Chile, Czech Republicand Japanwith 14, 11, 11, 10, 9, 8, 7, 7, 7, 5, 5, 4, 4and 4 Notifications, respectively. The remaining 36 Notifications were from other WTO Member countries.





TBT Notifications Relevant to India

This section covers details of notifications which are relevant to India and where a letter has forwarded to all relevant and interested stakeholders seeking their comments on the notification. Stakeholders include individual exporters, organizations, associations and government departments representing the product mentioned in these notifications.

InDecember 2018, there were 165 notifications issued by WTO member countries which were relevant to India.
